Good morning Aiden,

I hope things on the west coast are going well. I'm writing you this email to follow up on our discussion via text last weekend. As you know, we're approaching the 3 week agreement we made for the \$300 partial refund on the damaged t-600 statue. We agreed to this on 7/15 (via phone) and you emailed it in writing on 7/17 (see email chain below).

I've done my best to be flexible and accommodating from the beginning of this transaction, which was 2 months ago (6/4/15). You and I both know this transaction has been a mess: The initial shipping delays, 2 price increases (shipping materials then additional shipping), the damage to the statue, and finally the insurance fiasco with UPS because they did not approve of the packing. Regardless of where we point the finger, it hasn't been a good experience for me.

I hate having to write this email. It's a terrible position to be in, and I'm hoping we can avoid this outcome entirely. But, it's only fair to make you aware of where I'm at.

Please don't hate me for what I'm about to say. I have to send this message to protect myself, given the amount of money in play.

Way more packing material went into those boxes than shown in the photos right? Gaps of air = crushed statue. If those parts have packing gaps inside the boxes they'll get destroyed. Can we at least fill the void with peanuts? Those are usually a cheap alternative in this type of case.

I believe UPS requires a snug fit 2-3" of padding between the item and box

(all the way around!) to even honor an insurance claim.

If you filled them up right after taking the photos, then ignore what I'm saying. I just can't give affirmation to what I'm seeing. It's stressing me out big time.
